About, the New Westralia Shipping Company Prospectus.

- The New Westralia Shipping Company Pre-release Prospectus opened for offers on the 18th July 2024 for expressions of interest in supporting the New Westralia Executive in preparing the necessary financial documentation, administration support, professional appointments and Board positions to better represent the formation of the Company.
- The New Westralia Executive have established the exclusive right to ship from our Ports Geraldton, Fremantle, Albany and other our Ports of Australasia, carriage and conveyancing by General Postal Union Convention 1874 (Imperial), Sea Carriage of Goods Act 1924.
- Export Control Act 2020 attempts to effect a United Nations sanction law on the export of goods from our territories by use of extra territorial jurisdiction of no binding effect on the Colony.
- The Minister (Ports) for Western Australia may have the right of veto on laws repugnant to the interests of the Crown. The enabling act or authorisation of the Crown may be required to apply a sanction law that effects the Crown or a law of the Colony.

Export Control Act 2020, (Export Control Amendment (Ending Live Sheep Exports by Sea) Act 2024).

s429. Arrangements with States and Territories to assist in carrying out this Act

The Minister may enter into an arrangement with a relevant Minister of a State or Territory in relation to either or both of the following:

- (a) the use of any place in the State or Territory for the purposes of this Act, and the control and management of the place;
- (b) any matters necessary or convenient to be arranged in order to enable the Commonwealth, the State or the Territory to assist each other for the purposes of achieving the objects of this Act.

Note: The Secretary may also enter into arrangements with State or Territory bodies for officers or employees of those bodies to be authorised officers under this Act (see section 294).
