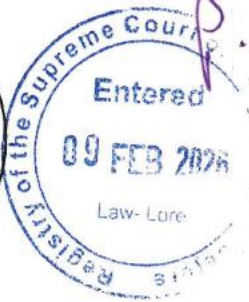

The New Westralia Colonial Government Proclamation.

Monday 9th February 2026.

Notice and Warrant of Execution (General/ Special).

Extraordinary General Meeting of Creditors.
Constitution Act 1889 (Constitution Act 1829).

By Order of His Majesty's Prosecutor – William Pumphrey, *Attornatus domini regis*, here seized of the law in right of the crown.

For the nullity of those laws repugnant to the laws of the Realm of England or injurious to the Colonial natives. The Company of Merchant Adventurers appear in Breach of Trust to the true intents and purpose of the Swan River Charter Grant of monopoly trade and administration, *Cygnis insignis*. Governor and Deputy Governors failure to produce a proper commission of office preventing proper investigation, obstructing, interfering and arresting *bona fide* Commissioner in service to the Crown.

Parliament may be unable to form responsible government on Dormant Commission, *this court* may be without lawful authority to make orders extra territorially, *Ipsa facto*.

All rights, liberty's and immunity's of Free Settlers and paramount and original equitable title owners preserved, Land Transfer Act 1874 notwithstanding.

Commonwealth of Australia Constitution Act 1900 (UK).

Clause 7. Repeal of Federal Council Act.

The Federal Council of Australasia Act, 1885, is hereby repealed, but so as not to affect any laws passed by the Federal Council of Australasia and in force at the establishment of the Commonwealth. Any such law may be repealed as to any State by the Parliament of the Commonwealth, or as to any colony not being a State by the Parliament thereof.

Federal Council of Australasia Act 1885.

1. An Act for shortening the Language used in Acts of the Federal *Council of Australasia*.
2. An Act to facilitate the Proof throughout the Federation of Acts of the Federal Council and of Acts of the Parliaments of the Australasian Colonies and of Judicial and Official Documents, and of the Signatures of certain Public Officers.
3. An Act to authorise the Service of Civil Process out of the Jurisdiction of the Colony in which it is issued.
4. An Act to make provision for the enforcement within the Federation of Judgments of the Supreme Courts of the Colonies of the Federation.
5. The Australasian Orders in Lunacy Act 1891.



Colonial Laws Validity Act 1865.

s2. Colonial law when void for repugnancy.

Any colonial law which is or shall be in any respect repugnant to the provisions of any Act of Parliament extending to the colony to which such law may relate, or repugnant to any order or regulation made under authority of such Act of Parliament, or having in the colony the force and effect of such Act, shall be read subject to such Act, order, or regulation, and shall, to the extent of such repugnancy, but not otherwise, be and remain absolutely void and inoperative.



A Conflict of Law .

WAPOL v ATHERTON PE 1251-1254/2025 (NO 777-781/2020)

Magistrates Court of Western Australia (Department of Justice) Uniform Law Application Act 2022 found repugnant to the laws of England, Colonial Legislation and the Statutes of the Realm (Imperial) attempting to seize the Crown by administrative malfeasance, misconduct default, Crown Estate Act 1961, (Crown Lands Act 1851).

 1. Governors Establishment Act 1992 abolished for want of law.
 2. Treasurer's Advance Authorisation Act 2025 rescinded in demand for the recovery of advance authorisations misappropriated by fraud - \$1 926 266 000.
 1. The Department of Parliamentary Services, the Board of Treasury, Treasury Corporation Act 1986, and the Board of Gold Corporation, Gold Corporation Act 1987 may be subject to indictment for fraud.

An Honest Claim of Right.

Criminal Code Act 1902 (Savings).
Chapter V – **Criminal Responsibility.**

Section 22.

IGNORANCE of the law does not not afford an excuse for an act or omission which would otherwise constitute an offence, unless knowledge of the law by an offender is expressly declared to be an element of the offence.

BUT a person is not criminally responsible, as for an offence relating to property, for an act done or omitted to be done by him with respect to any property in the exercise of an honest claim of right and without intention to defraud.
