Re re: Taking back Crown property 5th June 2024.

Greetings Mr Ashe,

For advice to the Governor and Deputy Governor and Common Council of the Company of Merchant Adventurers, *Cygnis insignis*.

1. Notice: The Swan River Crown Colony survives 1829 -2026.
 1. Clause 7 Commonwealth of Australia Constitution Act (UK), the Federal Council of Australasia, Constitution Act 1889 (UK).
2. Taking back Crown property 5th June 2024, typographical correction, highlighted on page 1 of 3 Constitution Act 1899 to be read in all future publications as Constitution Act 1889 (Imp) as attached.
 1. Magistrate William Pumphrey here standing for the office of government, taking charge of Parliament by dormant commission, executive officers to be vacated on political grounds, *Cygnis insignis*.
 2. Governors Establishment abolished, Prorogue of Parliaments for the Extraordinary general meeting of creditors, Consolidated Revenue Fund/ Exchequer, Parliamentary Services, Appropriations Act 1835 subject to audit and inquest, Audit Act 1881, Exchequer and Audit Departments Act 1866.
 3. The Governor, Deputy Governor and Common Council of the Company of Merchant Adventurers *Cygnis insignis* may be without lawful authority to issue orders or make agreements and subject to arrest for false or misleading statements. Admiralty has surety in these matters, the Office of the Lord Admiral may be subject to arrest for mutiny, Naval Discipline Act 1957 (1860).



3. In the Matter WAPOL v ATHERTON, PE 1251-1254/2025 (NO 777-781/ 2020) a Conflict of Law exists. Uniform Law Application Act 2020 (Victoria 2014) being repugnant to the laws of the Colony, Colonial Laws Validity Act 1865.
 1. For the safety of the Commissioner, *Force majeure* prevents performance (UNIDROIT 7.1.7).
 2. We instruct the Official Secretary to demand Admiralty withdraw all charges against ATHERTON, make safe the Crowns prerogative, *Perogativa Regis* 1322, protect the Commissioner in his rightful duties and restore the paramount law of the Colony without delay, Or, resign your office in disgrace on evidence of the Company's open hostility to the Crown and the collapse of trust *Ipsa facto*.
 1. Your position may be found untenable Mr Ashe.
 1. Have the Provost Marshal attend our person for the restoration of proper governance, *De jure* and the careful handover of authority.
 2. Have Treasury honour New Westralia Private Credit Voucher – Knots and prepare for the transfer of business.
 3. Vacate the office of acting Parliamentary Commissioner for Administrative Investigations for our taking up of those offices, and prepare to vacate other executive offices.
 4. Eject strangers, trespassers and ward against piracy and foreign incursion.
 1. United Nations Eviction Order 23.12.24.
 2. United Nations Ejectment Order 19.11.25.

Thank you for taking Notice Mr Ashe, these letters form evidence to the international community of the survival of the Swan River Colony and the competence to take charge of Colonial governance in these our safe hands.

Obstruction or interference of the Commissioner may be an offence against the Crown.

Without ill-will, vexation or frivolity.
